
Tagart was first elected to the MSC board in 2004, and has served on the organization's Marketing Committee. She is an attorney with Ronan and Firestone in Scottsdale.

optional guided hikes. A general hike and a special hike for children will be offered along with nature talks in the amphitheater. The subject will be the role of a wash in the Sonoran Desert.

For riders a special bring-your-own-horse equestrian ride will be held. Staff will also be present to discuss the amenities in the access area, including the environmentally friendly waste, power and building materials employed.

The access area is located off of 124<sup>th</sup> Street just north of the Cactus Street alignment (overflow parking will be available at Anasazi School at the southeast corner of the 124<sup>th</sup> Street/Cactus Road alignment).

# Thoughts from Carla, Executive Director

It's getting hot already and many of you are heading out of town, but before you go:

1) Please join us at what promises to be a wonderful grand opening of the Lost Dog Wash Access Area. It's so exciting to see these trailheads come on line and we owe a big "thank you" to our partners at the City of Scottsdale's Preservation Division for their hard work in planning and constructing what will soon become favorite entrances to the Preserve.

2) Please SIGN THE CONSERVING ARIZONA'S FUTURE PETITION!

We have gathered 230,000 signatures to date and I am pleased to report that currently the top two signature gatherers in the state are MSC members! We need 50,000 more signatures of registered Arizonans this month in order to have a sufficient safety bubble since many signatures will be invalid. Remember, this straightforward initiative will:

- Conserve 694,000 acres of some of Arizona's most important natural areas.

In the McDowell Sonoran Preserve, it will immediately protect 5,177 acres of state land in the McDowell Mountains and Granite Mountain; it will provide the opportunity for Scottsdale to sign a long-term purchase agreement without going to auction for an additional 9,347 acres that were reclassified as suitable for conservation under the Arizona Preserve Initiative; and this will maximize use of the existing preservation tax as Scottsdale works with the state to purchase the remaining 4,500 acres within the voter approved Preserve boundary.

- Require the state land department to cooperate with local communities for planning and conservation of state trust lands, and provide local authorities the power to limit and control development;

- Protect and enhance an essential classroom funding

stream thereby ensuring better Arizona schools, which are the building blocks of strong neighborhoods.

A strong statewide coalition for Conserving Arizona's Future has been built with key supporters, some of whom are: Arizona Business and Education Coalition (119 school districts and businesses, including Motorola, Intel, Cox, Boeing and Bashas), Arizona Education Association, Arizona League of Conservation Voters, Arizona League of Women Voters, Arizona Mountaineering Club, Arizona Native Plant Society, Arizona Public Service, Arizona School Administrators Association, Arizona State Horsemen's Association, Arizona State Parks, Audubon Arizona, Coalition of Pinnacle Peak, Desert Foothills Land Trust, Governor Janet Napolitano, Governor Bruce Babbitt, Lattie Coor, President Emeritus Arizona State University, Mayor Mary Manross, McDowell Sonoran Conservancy, Mountain Bike Association of Arizona, National Parks Conservation Association, Phoenix Mountains Preservation Council, Scottsdale Area Chamber of Commerce, Sonoran Institute, Superstition Area Land Trust, The Nature Conservancy in Arizona, Trust for Public Land, Valley Forward Association with more than 250 member groups, Valley Partnership, Arizona's 11th largest trade organization, representing 500 companies.

We have come a long way but there is still the real possibility that the Legislature will refer an insufficient, competing "spoiler" measure to the ballot in order to confuse voters. In addition, running a statewide campaign for what promises to be a chock full November ballot will not be easy and it will be expensive. We still need your help. This summer we will be holding a special meeting to honor our signature gatherers and announce campaign activities. We will send out an email to our Friends and have numerous newspaper articles as the date gets closer. Please watch for them.



# Bike Patrols Improve Trail Coverage

Now in its second year of operation, the MSC Mountain Bike Steward Patrol has been a tremendous asset in helping Stewards patrol large areas of the McDowell Sonoran Preserve and nearby State Trust Lands.


“There are nearly 16,000 acres and 100 miles of trails in Preserve and State Trust Lands in the area northeast of Pima road and Dynamite,” explained B. J. Heggli, lead steward for the Pima area and Mountain Bike Patrol. “It would be extremely difficult to cover this much area on foot; the bikes allow us to cover more ground, more often.”

In addition to providing random patrols, the mountain bikers also perform remote trail maintenance projects, litter pick-up, and provide information and assistance to all trails users in the area. The group works closely with the City of Scottsdale Preservation Staff, Arizona Game and Fish, and the Arizona State Land Department.

Members of the Mountain Bike Patrol are easily recognized on the trails by their bright yellow shirts.

“We’re starting to see some recognition of the group from many users on the trail,” explained Heggli. “Because we’re in an area where we encounter other bikers, hikers and also various types of motor vehicles, we needed the bright yellow shirts primarily for visibility from a safety standpoint, but now we’re finding that people are starting to recognize who we are and what we do.”

## New MSC Field Guide Available Late May



You can be among the first to get a copy of the new Field Guide to the McDowell Sonoran Preserve, being published by the McDowell Sonoran Conservancy. The approximate 130-page guide features information and photos on plants, animals, geology and cultural history of the Preserve, and well as trail maps.

“The Field Guide has been a labor of love for many of our Stewards” explained Fred Klein, an MSC Steward and editor of the guide. “We’ve learned that the more people know about the Preserve, the more they appreciate it... it’s designed to easily fit in a back-pac for on-the-trail reference.”

Initial delivery of the Field Guide is scheduled for late May. Cost is \$15, plus shipping and handling. The guide can be ordered by calling the MSC office at 480-998-7971, or by going to the website at [mcdowellsonoran.org](http://mcdowellsonoran.org).

To qualify to become a member of the bike patrol, individuals must have completed the MSC Steward or Assistant Steward training courses, and must demonstrate basic mountain bike skills and equipment handling prior to assignment with the patrol. The bikers carry maps and other information on the Preserve for distribution to people they encounter on the trails, and also generally carry basic emergency and first aid supplies.

Heggli added that there are plenty of openings for additional bike patrol members.

## Chairman's Message

By now, you've read of the Preservation Golf Tournament on June 2 at Troon North. I hope you'll join us in support of the McDowell Sonoran Conservancy's stewardship, education and advocacy programs that have helped sustain Scottsdale's vision of preserving one-third of our City.

Although this is the first year for the tournament to be held at Troon North, it marks the second year of the tournament as an MSC fundraiser. Les Conklin of the Greater Pinnacle Peak Association initiated the idea for the tournament, spearheaded its organization and gathered sponsors to help make it successful last year.

Chairing this year's event for MSC is Barbra O'Brien, a former LPGA Tour player, and now a leading golf instructor. She has been honored with the LPGA's "Master Professional" designation, received numerous regional and national awards for instruction, and has been voted National LPGA Teacher-Of-The-Year by her peers.

As for the course itself, in the high desert north of Scottsdale, Troon North Golf Club stands as the hallmark of the desert golf experience, stretching through the natural ravines and foothills in the high Sonoran desert in the shadows of Pinnacle Peak. The challenge, visual sensation, and special ambiance of Troon North set the standards by which all others are measured.



In addition to the unparalleled golf



## Preserve Up Close



### Javelina

Although they look like pigs to most people, the collared peccary, more popularly known as the javelina, is no more closely related to the pig than it is to the hippopotamus. While the resemblance to pigs is obvious, there are notable differences between the two.

Javelina are much more social than pigs, forming permanent herds, noted by cooperation and little competition among members. They are nearly exclusively herbivorous (although they sometimes will eat insects) while pigs are omnivorous.

Javelina are smaller, adults generally weighing around 50 pounds or so, while many pigs can weigh ten times that much. And javelinas have a scent gland on their backs that produce odor; with their frequent physical contact with each other, herds often develop a distinct odor all their own.

Javelinas tend not to be dangerous, but like all wild animals, are best viewed at a distance. If startled, they may dash off in multiple directions, and with their generally poor eyesight, you could end up an unintentional target. And hand-feeding can be dangerous and should be avoided.

MSC lost a dear friend this spring with the passing of Myrna Smith. She was one of our first Preserve Stewards, a popular hike leader and a very dedicated volunteer not only with our organization but the McDowell Park Association as well.

While we will miss her dearly, Myrna's spirit will live on in this land she loved and fought for.
